



E-MAIL/FACSIMILE/ ONLINE PORTAL/ELECTRONIC MEDIA-RELAIED INSTRUCTIONS AUTHORITY AND INDEMNITY

TO: UNITED NATIONS DEPOSIT TAKING SAVINGS AND CREDIT COOPERATIVE SOCIETY LIMITED. (UN DT SACCO)

It would be convenient and in my interests if I could at any time and from time to time send instructions by electronic mail/media means (meaning the sending of transmissions electronically between computers via the telephone networks /electronic devises) and/or means of Facsimile transmissions (meaning the sending of transmissions between Facsimile machines via the telephone networks) to UN DT SACCO in relation to any and all my existing accounts, facilities, loan guarantees and other arrangements with UN DT SACCO and any accounts, facilities which I may now or in the future have with UN DT SACCO or in which I may offer myself as guarantor. (Instructions sent by such transmissions being hereinafter referred to as "E-mail/ mobile banking/online portal instructions"). In consideration of UN SACCO agreeing to accept Email/mobile banking/online portal instructions from me as aforesaid, I agree: -

1. **THAT** UN DT SACCO may act on any E-mail/mobile banking/online portal instructions given by me from time to time, and I voluntarily and with full knowledge take and assume any and all risks associated therewith absolutely.
2. **THAT** once E-mail/mobile banking/online portal instructions have been sent to UN DT SACCO purported by me (the person specified below), UN DT SACCO shall not be liable for the authenticity/accuracy of such E-mail/mobile banking/online portal instructions purporting to have been sent by me & may act thereon as if the same had been duly given by me;
3. **THAT** in acting on E-mail/mobile banking/online portal instructions, UN DT SACCO shall be deemed to have acted properly and to have fully performed all the obligations owed to me, notwithstanding that such E-mail/mobile banking/online portal instructions may have been initiated, sent or otherwise communicated in error or fraudulently, and I shall be bound by any E-mail/mobile banking/online portal instructions on which UN DT SACCO may act if UN DT SACCO has in good faith acted in the belief that such E-mail /mobile banking/online portal instructions were given by me;
4. **THAT** UN DT SACCO may, in its absolute discretion, decline to act on or in accordance with the whole/any part of an E-mail/mobile banking/online portal instruction pending further enquiry or further confirmation (whether written or otherwise) from me, so however that UN DT SACCO shall not be under any obligation to so decline in any case & UN DT SACCO shall in no event or circumstance be liable for so declining; and
5. **TO** release from and indemnify against all claims, losses, damages, costs and expenses whatsoever arising in consequence of, or in any way related to UN SACCO having acted in accordance with the whole or any part of any E-mail/mobile banking/online portal instruction exercised (or failed to exercise) the discretion conferred upon UN DT SACCO in Clause 4 above.

I confirm that I have read and understood the information as provided in this instrument and agree to be bound by the same fully. I further confirm that all the information and documentation I submit to UN DT SACCO via electronic media will be authentic, true and accurate to facilitate processing and that UN DT SACCO shall be entitled to treat such documentation as genuine and authentic at face value.

3. The form must be received at the UN DT SACCO in its original hard copy for it to be authentic and filed and acknowledged.
4. The names, email address, phone number and signature must be the same as the ones in a member record with the SACCO. Forms with different personal details will be not be accepted.
5. The member is advised to read and fully understand the terms of the indemnity before signing and submitting to the SACCO.
